### **Product Standard Warranty**

The products purchased from Visir Inc. and/or an authorized Visir distributor/dealer are covered by this Warranty.

## 1.0 Warranty Coverage

We warrant that if the product FAILS TO PERFORM under REGULAR USE AND MAINTENANCE CONDITIONS due to material, craft, or manufacturing problems, we will provide you with warranty as specified herein during the warranty period. "REGULAR USE AND MAINTENANCE CONDITIONS" means that the product is installed, used, maintained, stored, transported, etc. conforming to the instructions for use and the reasonably expected purpose or use. "FAILS TO PERFORM" means that the product does not perform the functions described in its standard performance parameters. We do not charge you for warranty service except as stated in advance or at your expense as required by law or by agreement.

## 2.0 Warranty Period

We provide different warranties for different types and parts of products as set out below. The warranty period starts from the date of purchase as indicated on the invoice.

In order for the warranty to apply, and to claim under the warranty, you must present the original invoice received at the time of purchase of the product in question, to us when you wish to make your warranty claim.
